Submission of Online Application Form, Document Verification, Confirmation of Application Form at ARC and Submission of Option form for Admission to First Year of Four Year Degree Courses in Engineering/Technology for academic year 2013-2014

This notification is being issued for Submission of Online Application Form, Document Verification and its Confirmation at Application Receipt Centres (ARC) by candidates willing to be admitted in Autonomous Colleges, State Government/Aided Colleges, University Managed Institutes, University Departments, Unaided colleges and/or such number of seats from Unaided colleges, which by mutual consent have decided to form part of this admission process of Engineering/Technology Courses for the Academic Year 2013-14.

Minimum eligibility criteria for applying to admission to these courses are as mentioned in the Information Brochures issued at the time of submission of application form for MT-CET 2013 and to be issued at the time of submission of online Option form.

The "**Online Application Form**" is being made available to only those eligible candidates, who are desirous of seeking admission to the aforesaid colleges through Centralised Admission Process, on the official website www.dte.org.in/fe2013.

Aspiring candidates are required to fill in the Online Application Form, take the printout and submit the duly signed form in person along with required documents for confirmation at ARC's as per schedule. Candidates should produce original documents for verification and collect receipt cum acknowledgement duly signed by the ARC Officer. The merit list of eligible candidates for Centralised Admission Process (CAP) will be displayed on website.

Applications received by post at ARC/DTE office will be rejected and no communication in this regard will be made.

Important Note:

1. It is MANDATORY for all eligible aspiring Maharashtra State, JEE Main 2013 (Paper 1) qualified and J&K Migrant candidates to submit and confirm Online Application Form for admission.
2. JEE Main 2013 (Paper 1) qualified candidates should submit & confirm the application form in-person at ARC, by making payment of application fees Rs. 700/- (Rs. 500/- in case of candidates of Backward class categories belonging only to Maharashtra State) by way of DD/Pay order in favour of "The Director, Technical Education, Maharashtra State" Payable at "Mumbai" drawn on any Scheduled/Nationalised/Commercial Bank
3. Maharashtra State candidates appeared for MT-CET 2013 and also aspiring for admission against All India seats, on the basis of JEE Main 2013 (Paper 1) should apply for All India Seats through the same application form along with payment of application fees as described at Sr. No 2 above.
4. J & K Migrant Candidates should send duly signed print out of online Application Form and attested copies of required documents by hand/speed post/courier for confirmation along with a DD/Pay order of Rs. 700/- to the following address on or before the dates given in the schedule.

J&K Migrant Candidate will get the *Receipt-cum-Acknowledgement* through their login after confirmation of application form. Applications received late will be rejected.

5. J&K Migrant and GoI Candidates are required to read the modified eligibility criterion regarding admission from the Information Brochure available Online.
6. Candidates who have filled in and confirmed the aforesaid Online Application form at ARCs and who have been assigned a Merit No. shall only be eligible to participate in the CAP.
7. If candidates fail to confirm online filled application form at ARC, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of CAP and shall not be able to participate in the CAP.

Centralized Admission Process (CAP):

The Competent Authority shall conduct total Three (3) rounds of Centralized Admission consisting first Two (2) rounds of Centralized Allotment wherein eligible candidates will fill separate/fresh Online Option forms for respective rounds and Third round of CAP shall be conducted by way of counseling only for the eligible Maharashtra State candidates.

Document Verification and Confirmation at Application Form Receipt Center :

The candidates are required to carry ALL Original Certificates and one set of attested true copies of these documents as mentioned in information brochure issued at the time of submission of application form for MT-CET 2013. The list of documents required is given in the information brochure and will also be listed in the printout of the online application form. In no case, any documents will be accepted after the last date of verification and confirmation of the Online Application Form. If the candidate fails to submit the required documents to substantiate the claim for reservation (caste/validity/ physically handicap/defense), the candidate will not get the benefit of the reservation.

General Instructions:

1. The candidate must report in person to ARC for verification of documents & confirmation of online filled application form as per the schedule.
2. Reserved category candidates who could not produce caste/tribe validity certificate at the time of confirmation of application form at ARC can confirm their application in their respective category by producing caste certificate; however it is mandatory for such candidates to produce the caste/tribe validity certificate at the time of reporting to the institute for admission.
3. The 'Mock Allotment' stage is introduced for CAP Round I to enable the candidate for better approach for the choice of seat. The allotments made / displayed at the 'Mock Allotment' stage are only indicative and do not create any right what so ever in favour of or against any candidate. The candidate can not claim the allotted seat in the Mock Allotment for admission and in no case should report to the allotted institute.
4. The Candidate has to submit and confirm the Online Option/preference Form for CAP Round I/II through candidate login by himself/herself from the place convenient to him/her. It is not required to report to ARC for confirmation of option form.
5. Candidate can avail the facility available at ARC for confirmation of option form. For availing the facility of ARC candidates are required to pay Rs. 50/- in cash as facilitation fee to ARC.
6. It will be the responsibility of the candidate to submit and confirm the online Option form by himself/herself through their Login.
7. Candidate can modify preferences, add choices and delete choices before confirmation of the online option/preference form.
8. The Option/preference form just submitted, but not confirmed by the candidate himself/herself will not be processed for allotment for respective CAP Rounds.
9. The online Option/preference form once confirmed by the candidate can not be modified / cancelled.
10. Candidate should keep the printout of the online option/preference form after confirmation by the candidate for future reference.
11. Candidates are required to pay Rs.100/- in cash as a processing fee for CAP Round III (Counselling Round) at the Counselling Centre.
12. All institutes will remain open between 11 am to 5 pm on all days of reporting (including holidays).
13. All ARC's shall remain open on all days including holidays and sundays for submission & confirmation of application form/verification of documents/submission & confirmation of option form during the schedule.
14. The schedule displayed above is provisional and may change under unavoidable circumstances. The revised schedule, if any, will be notified on website www.dte.org.in/fe2013. Information Brochure:
