Dear Sir/Madam.

This is in continuation to PCI circulars no.s - 14-3/2019-PCI dt. 20.04.2020 and 09.07.2020 insisting for payment of salary to teaching faculty during COVID-19 pandemic lockdown.

It has come to the notice of the council that some institutions

- a) are not paying salary to the teaching faculty.
- b) have even terminated the services of the teaching faculty.

In this connection, it is clarified that release of salary to the teaching faculty has to be strictly done. Please provide the following information.

- a) Bank statement of salary paid to the teaching faculty from January 2020 onwards and continue adding every months thereafter on the dashboard of your institution.
- b) Months wise details of the teaching faculty on institution's rolls. If any of the faculty has resigned or has been terminated, the details of the same need to be provided giving proper justification along with evidence of the staff appointed in the vacancy so created in the following formats.
