Hon'ble Supreme Court of India vide its order dated December 15, 2014 passed in I.A.No.9/2014 Special Leave Appeal (C) No. (s) 7277/2014 titled as Orissa Technical Colleges Association v/s AICTE & Ors. has granted interim relief, as prayed for in I.A.No.9,i.e.

- a. Extend the interim orders dated 17.04.2014 and 09.05.2014 for the academic session 2015-16 and/or
- b. Direct that prior approval of AICTE is compulsory and mandatory for conduct of a technical course including the MBA/Management course by an existing affiliated Technical college and also new technical college which will require affiliation by a university for conduct of its technical courses /Programmes for the academic session 2015-16.

In view of the above, AICTE invites applications for approval from all technical institutions including affiliated **Technical Colleges** and also new **Technical Colleges** which will require affiliation by a University for conducting technical programs/ courses including courses of MBA/Management for the academic year 2015-16 as per the following:

- (a) Applications are invited for "Setting up New Technical Institution offering Technical Programs (Engg & Tech. / Pharmacy / Architecture / Town Planning / Applied Arts & Crafts / Management / MBA / PGDM / HMCT / MCA) at Degree/Post Graduate Degree / Diploma / Post Diploma level affiliated to universities".
