### Online Registration, Document Verification & Confirmation

With reference to Higher & Technical Education Department GR No. TEM-2016/CR-381(A)/ TE-4 Dated 21st July 2016, the Government has decided to give an opportunity to all eligible candidates aspiring for admission to various Professional Technical Courses. All the eligible candidate who have failed to complete the process of registration, document verification and confirmation due to various reasons for participating in Admission Process, can now participate in Admission Process to be carried out at Institute Level. However such candidates shall be considered eligible for admission only after exhausting candidates whose name have appeared in the earlier Final Merit List published by the Competent Authority. Candidates having their names in Final Merit List published earlier by the Commissioner and Competent Authority, State CET Cell need not apply again.

Following types of candidates shall be eligible for Registration and Document Verification at Admission Reporting Centre (ARC) during this extended period.

1. Candidates who failed to apply for these admissions.

2. Candidates who applied but could not complete the document verification and confirmation.

3. Candidates who were not eligible but completed verification and confirmation application and are now eligible.

- The Institutes shall admit the Candidates after admitting the candidates whose names appeared in earlier Final Merit List published by Competent Authority for CAP Rounds.
- 4. In no case (Irrespective of their marks), the Candidates appearing in this Separate Final Merit List will claim preference over the Candidates appearing in earlier Merit List.
