**Sub: Reservation of seats in degree/diploma level technical courses for states /
UTs lacking such facilities -Academic Session 2016-17.**

Sir/Madam

This is regarding on-going scheme of reservation seats in Engineering/
Technology/Architecture/ Pharmacy courses conducted at degree level/ technical
institution approved by the All India Council for Technical Education(AICTE) and
universities for States and UTs which do not have engineering colleges or lack facilities
for education in specific field of Technical Education.

2. Since last year(Academic year 2015-16) the Central Seat Allocation Board has
been managing the online Counselling for these students of above State/UTs who
qualified JEE (main examination). CSAB-16 is being managed by NIT, Patna. A meeting
of regional centres of these States/UTs with the CSAB team was held on 29.6.16
wherein among various issues the following were also discussed:

- i) The students of States/UTs request that the fee structure of the host institutes
be made available before hand to enable them to take an informed decision.
 - ii) Despite the verification being done by the States/UTs in some cases the
colleges tend to verify again and send back the students on flimsy reason.
3. It is felt that AICTE may kindly bring the above to the notice of the colleges to
mention the fee structure of the courses earmarked for their students on their website

and request them to update the details of students on their website and intimate TE Depts/CSAB-2016.
